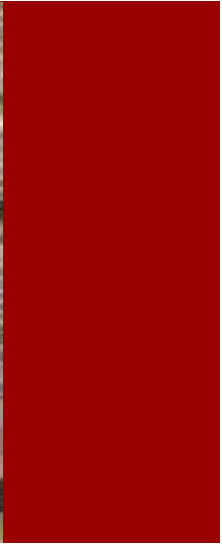

Dreamsweaver Limited Terms & Conditions of use of Tapeley Park

1. CONDITIONS

A completed and signed Agreement Form and appropriate deposit payment is required within 14 days of the original verbal booking. Failure to do so will result in Dreamsweaver Ltd allowing other customers to book the specified date, as the provisional booking will be deemed as cancelled.

2. DEPOSITS-Weddings:

We require a non-refundable deposit of £500 to be sent with a signed copy of the agreement form. A further 50% of the estimated outstanding balance is to be paid 3 months prior to the wedding. The remaining 50% of the estimated outstanding balance is payable 1 month prior to the wedding. Any additional costs incurred on the day will be settled within 7 days otherwise a 10% surcharge may be incurred.

DEPOSITS-Functions:

We require a non-refundable deposit of £200 to be sent with a signed copy of the agreement form. The remainder of the estimated outstanding balance is payable 1 month prior to the event. Any additional costs incurred on the day will be settled within 7 days otherwise a 10% surcharge may be incurred.

3. LOSS OR DAMAGE

The client is responsible for any loss or damage caused to Tapeley Park or any equipment hired to the client, hired by the client or the client's guests.

4. CONFETTI

No paper confetti is to be used on the Grounds of Tapeley Park- Only bio degradable confetti may be used.

5. FINISHING TIMES

Functions must finish at Midnight unless by prior written arrangement.

6. NUMBERS ATTENDING

In order to comply with Fire and Safety regulations the maximum number of guests quoted in the attached letter must not be exceeded.

7. CANCELLATIONS

Due to the size and nature of the business at Tapeley Park it is necessary to operate the following cancellation policy:

Initial deposit is non-refundable

3 months prior to event/rental 50% of the balance is charged

2 months prior to the event a further 25% will be charged.

1 month prior to the event there will be a 100% cancellation charge.

In the event of cancellation by the client, Dreamsweaver Ltd will endeavour to re-let the venue with similar catering arrangements. The cancellation charges will be reduced at the discretion of management if costs can be recouped.

We strongly recommend that you take out your own appropriate insurance.

8. CANCELLATION BY DREAMSWEAVER LTD

Dreamsweaver Ltd reserves the right to cancel the booking if: Any part of Tapeley Park is closed or unavailable because of an event beyond the Park's reasonable control, the booking may, in the reasonable opinion of the Park, damage the reputation of the Manor. All booking fees will be refunded in full.

Tapeley Park has the right to refuse entry to any guest.
